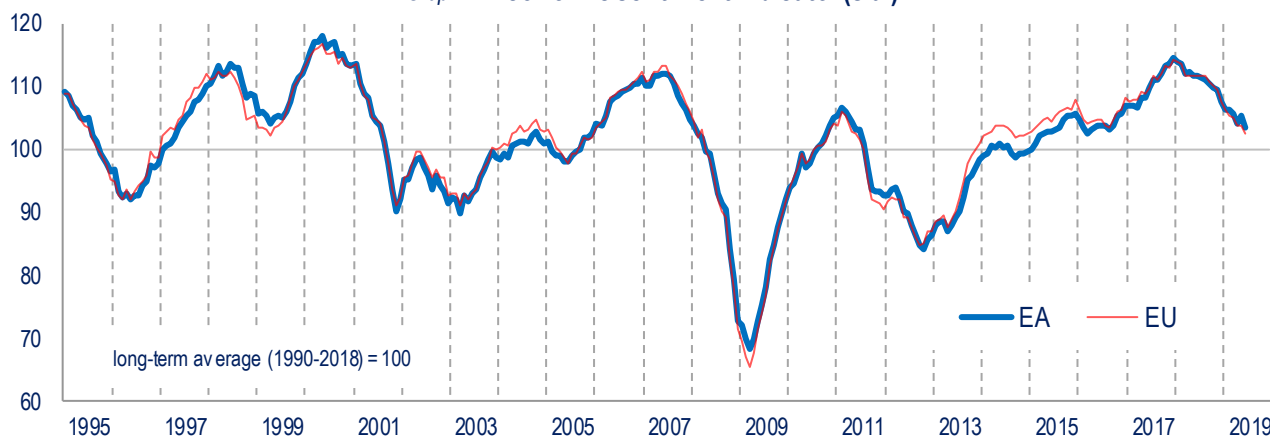

June 2019: Economic Sentiment decreases markedly in both the euro area and the EU

In June 2019, the *Economic Sentiment Indicator* (ESI) decreased markedly in both the euro area (by 1.9 points to 103.3)¹ and the EU (by 1.5 points to 102.3).

Euro area developments

The deterioration of euro-area sentiment was driven by lower confidence in industry and, to a lesser extent, in services and among consumers, while confidence improved in retail trade and, particularly, construction. The ESI decreased in all of the largest euro-area economies, most so in Germany (-2.9), followed by Italy, the Netherlands (both -1.5), France (-1.0) and Spain (-0.6).

Industry confidence posted a sharp decline (-2.7), which constitutes, together with a commensurate drop in April, the most significant decrease in about eight years. The latest deterioration brought the indicator for the first time since autumn 2013 slightly below its long-term average and was caused by managers' more pessimistic views on all three components, i.e. *production expectations*, the *current level of overall order books* and the *stocks of finished products*. Of the questions not included in the confidence indicator, managers' appraisals of *export order books* worsened, too, whereas *past production* was assessed markedly more positively. The decline in **services confidence** (-1.1) was driven by managers' more pessimistic views on all its components, i.e. the *past business situation* and *past demand*, as well as *demand expectations*. **Consumer confidence** eased (-0.7), reflecting households' more negative views on all its components, namely their *past and future financial situation*, their *expectations about the general economic situation* and their *intentions to make major purchases*. **Retail trade confidence** improved (+1.0) on the back of managers' better assessments of the *present and expected business situation*, which were only partly outweighed by somewhat worsened views on the adequacy of the *volume of stocks*. **Construction confidence** bounced back (+3.6) from a sharp decline in May, thanks to a strong rebound in managers' *employment expectations* and a slight improvement in the appraisals of the level of *order books*. Finally, **financial services confidence** (not included in the ESI) remained broadly unchanged (-0.3), as managers' deteriorated appraisals of the *past business situation* and more muted *demand expectations* were outweighed by more benign views on *past demand*.

While **employment plans** in construction saw a marked rebound from last month's drop, industry posted a strong decline, which (together with the one in March) constitutes the sharpest drop since 2012. Meanwhile, employment plans stayed broadly unchanged in retail trade and improved in services. **Selling price expectations** came down in industry, retail trade and construction, while they grew in services. In line with the prevailing trend, consumer price expectations eased as well.

EU developments

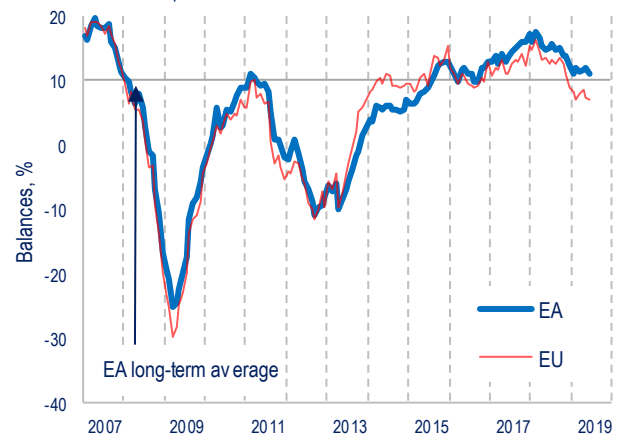
The marginally smaller decline of the EU ESI (-1.5) was mainly due to more upbeat sentiment in Poland (+1.9) and the UK (+0.6). Compared to the euro area, confidence in industry and services eased less, booked smaller increases in construction and deteriorated in retail trade. EU consumer and financial services confidence developed in line with the euro area. Employment expectations differed in so far as they remained broadly flat in services, improved in retail trade and grew to a lesser extent in construction. Price expectations followed euro-area trends.

¹ Business confidence indices for France were revised compared to the May press release; the net effect is an upward revision of the ESI for May of 0.1 points in the euro area (to 105.2).

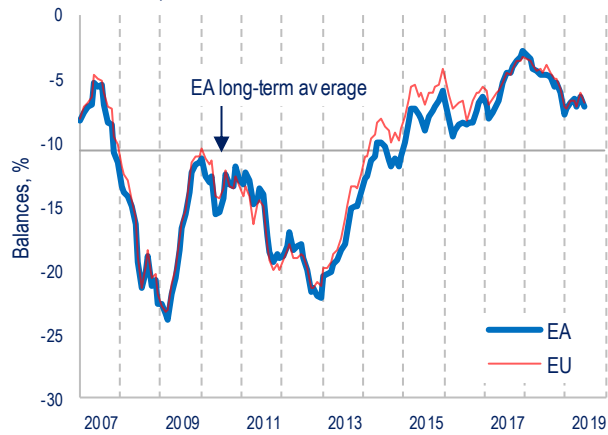
Graph 2: Industrial confidence indicator



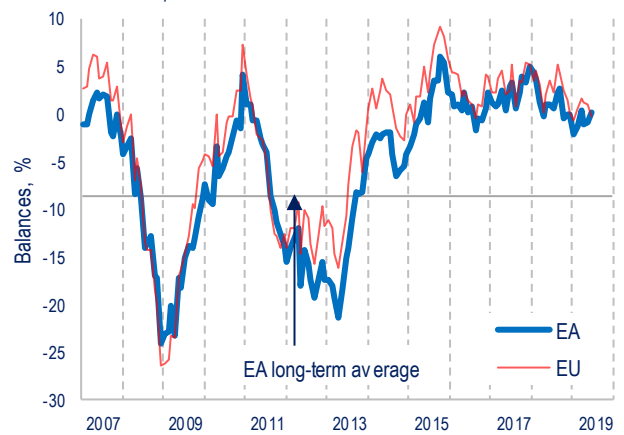
Graph 3: Services confidence indicator



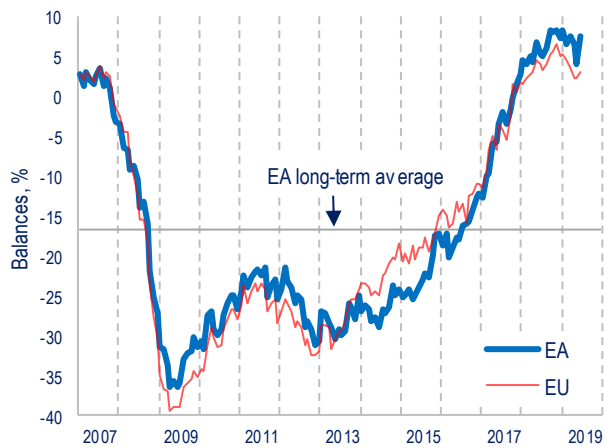
Graph 4: Consumer confidence indicator



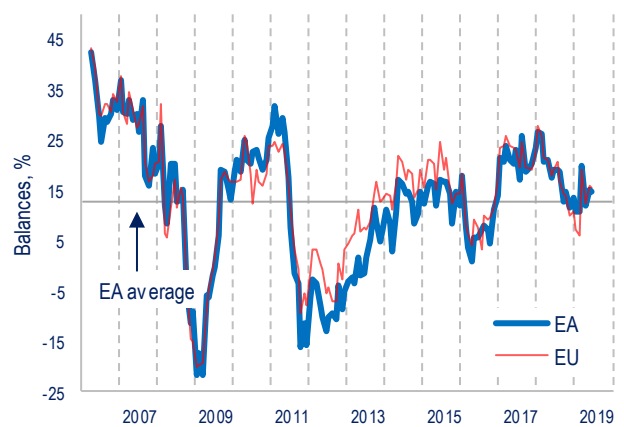
Graph 5: Retail trade confidence indicator



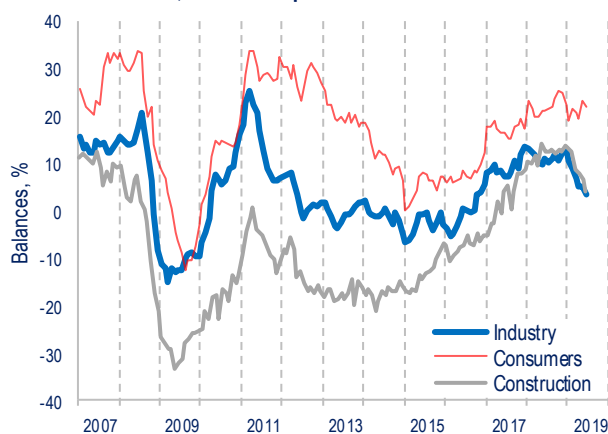
Graph 6: Construction confidence indicator

Graph 9: Employment and unemployment in the EA

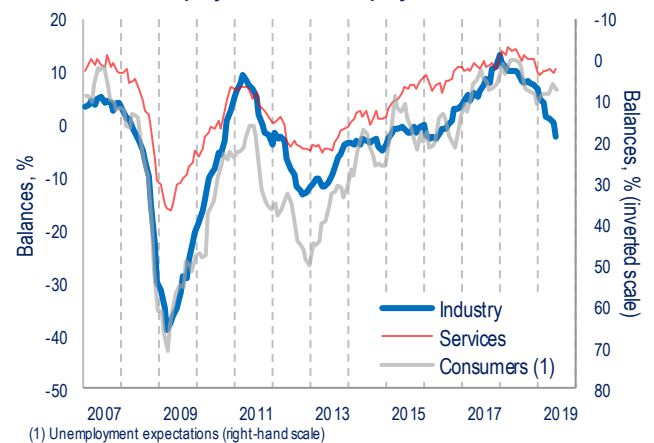
