


## FLASH CONSUMER CONFIDENCE INDICATOR FOR THE EU AND EURO AREA

In April 2023, DG ECFIN's flash estimate<sup>1</sup> of the consumer confidence indicator<sup>2</sup> resumed its recovery, improving by 1.7 percentage points (pps.) in the EU and 1.6 pps. in the euro area (EA)<sup>3</sup>. At -18.9 (EU) and -17.5 (EA) pps., consumer confidence remains, however, well below its long-term average.

<sup>1</sup> This month's Flash CCI for the EU aggregate is computed on the basis of consumer survey data from 25 EU countries (all except Ireland and Romania), covering 97% (EU) and 98% (euro area) of the total private final consumption expenditure.

<sup>2</sup> The consumer confidence indicator builds on replies to selected questions addressed to consumers according to the Joint Harmonised EU Programme of Business and Consumer Surveys. ### Information

**Data collection period:** April 1-19.

**Release policy of the Consumer Confidence Indicator (CCI):** Every month, the Directorate-General Economic and Financial Affairs (DG ECFIN) of the European Commission releases the flash CCI for the EU and euro-area aggregates, using the data available on the cut-off date. The final Consumer Survey results are then published as part of the full Business and Consumer Survey release at the end of the month.

The Joint Harmonised EU Programme of Business and Consumer Surveys is managed by DG ECFIN's Unit Economic situation, forecasts, business and consumer surveys (A3), Sector Business and consumer surveys and short-term forecast.
